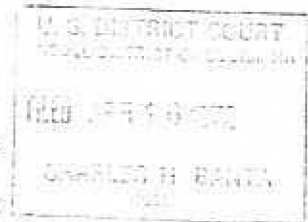

ORDER APPOINTING REFEREE
IN BANKRUPTCY AND HIS
CLERKS AND OTHER EMPLOYEES

GENERAL ORDER
NUMBER 8

WHEREAS, the Act of December 18, 1971 created the above entitled District; now, therefore, pursuant to the authority granted by 11 U.S.C. 62 and 63,

IT IS HEREBY ORDERED that:

1. HARVEY H. POSNER, serving as a Referee in Bankruptcy in and for the Eastern District of Louisiana, Baton Rouge Division, immediately prior to the effective date of said Act, is hereby appointed as Referee in Bankruptcy for the Middle District of Louisiana, with the same powers, duties and jurisdiction, and at the same salary, as existing immediately prior to the effective date of said Act, except that his territorial jurisdiction will be limited to the Middle District of Louisiana as created by said Act; and


2. All clerks, reporters and other employees employed in the office of said Referee in Bankruptcy immediately prior to the effective date of said Act, are hereby appointed to the same respective positions for the above entitled Court, with the same powers and duties and at the same respective grades and salaries, with credit to be given in future promotions and step increases in salary for past services.

3. The said Referee in Bankruptcy and all clerks, reporters and other employees, employed in the office of said Referee, will continue in office as Referee, clerks, reporters and other employees in their respective positions for the United States District Court, Eastern District of Louisiana, Baton Rouge Division, as it existed prior to the effective date of the Act, for the purpose of performing such duties as may devolve upon them by statute for the Eastern District of Louisiana, Baton Rouge Division, as it existed prior to the effective date of said Act.

4. In the event individual appointments may be required, such appointments will be effective as of the effective date of said Act.

This Order shall become effective commencing April 16, 1972.

ORDER APPOINTING HONORABLE HARVEY H. POSNER
REFEREE IN BANKRUPTCY

By virtue of an Act of Congress approved July 1, 1898, and entitled: "An act to establish a uniform system of Bankruptcy throughout the United States" and the Amendatory Acts thereunder, particularly the Act of June 28, 1946, (60 Stat. 324), and May 16, 1951, (65 Stat. 42):

IT IS HEREBY ORDERED that HARVEY H. POSNER, Esquire, be, and he is hereby reappointed part-time Referee in Bankruptcy for the Middle District of Louisiana, under said Act, for the term of six years commencing at 12:01 o'clock a.m. on November 16, 1973. The said District consists of the Parishes of Ascension, East Baton Rouge, East Feliciana, Livingston, Pointe Coupee, St. Helena, West Baton Rouge, Iberville and West Feliciana.

It shall be the duty of said Referee, among other things, to preside at the first meeting of creditors and he is hereby vested with all the powers which are conferred upon Referees by said Act of Congress and he shall perform all duties which are by said Act of Congress imposed on Referees.

The said Referee shall take and return to the Clerk of this Court, to be filed by said Clerk, the Oath of Office as prescribed by Sections 712 and 1757 of the Revised Statutes of the United States on or before November 15, 1973.

IT IS FURTHER ORDERED that the Clerk of this Court enter this order of record on the minutes of the Court at the City of Baton Rouge, Louisiana, and deliver a certified copy of the same to the Referee hereby appointed.
