ORDER OF COURT APPOINTING UNITED STATES MAGISTRATE

In accordance with the authority conferred by 28 U.S.C. §631 et seq., and the further authority granted and action taken by the Judicial Conference of the United States,

IT IS ORDERED that FRANK J. POLOZOLA be, and he is hereby appointed as Full-Time United States Magistrate for the Middle District of Louisiana at the salary of \$30,000.00 per annum as fixed by the Judicial Conference of the United States, with his official station being designated as Baton Rouge, Louisiana.

Said United States Magistrate shall enter upon the performance of his duties at 12:01 a.m. on the 1st day of October, 1973, but prior to the commencement of such duties he shall take the oath or affirmance prescribed by 28 U.S.C. §§453 and 631(f).

The said Full-Time United States Magistrate is to hold and discharge the duties of his office for a term of eight (8) years from the date of his appointment subject to the provisions of 28 U.S.C. §631(c), unless sooner removed.



WHEREAS, the Act of December 18, 1971, created the
above entitled District; now, therefore, pursuant to Chapter 43,
Title 28 of the United States Code,

IT IS ORDERED that:

1. A. LEON HEBERT, United States Magistrate in and
for the Eastern District of Louisiana, Baton Rouge Division,
holding office immediately prior to the effective date of said
Act, is hereby appointed as United States Magistrate for the
Middle District of Louisiana for the remainder of the term
for which he was appointed as United States Magistrate for the
United States District Court, Eastern District of Louisiana,
Baton Rouge Division, with the same powers and duties as conferred
upon him by statute, by the respective orders of appointment, and
any subsequent orders; and

2. All full-time employees employed by said United
States Magistrate and paid by the United States are hereby appointed
in the above entitled District to the same positions now held by
each of them, with the same powers and duties and at the same
respective grades and salaries with credit to be given in future
promotions and step increases in salary for past services; and

3. The United States Magistrate and said employees are hereby continued in their respective offices for the United States District Court, Eastern District of Louisiana, Baton Rouge Division, as it existed prior to the effective date of said Act, by statute, by the respective orders of appointment and any subsequent orders.

4. In the event individual appointments may be required, such appointments will be effective as of the effective date of said Act.
