PANDEMIC RELATED CURTAILED OPERATIONS

AMENDED ADMINISTRATIVE ORDER

The Court's previous PANDEMIC RELATED CURTAILED OPERATIONS Administrative Orders are hereby superseded. This Order shall govern Court operations until further Order or until rescinded.

1. Extension of CARES Act Authorization

The undersigned, Chief Judge for the United States District Court for the Middle District of Louisiana, has reviewed the CARES Act authorization of the use of video and telephone conferencing set forth in Section 15002(b)(1) of the Act. The undersigned Chief Judge finds that for reasons of health and safety in the course of the continuing COVID-19 pandemic, the Court's Order authorizing proceedings to be conducted by video conference or telephone conference is hereby extended for an additional 90 days or until further Order of this Court under the authority of CARES Act § 15002(b)(3)(A).

2. Court Operations

In-person filings will not be accepted by the Clerks of the District or Bankruptcy Court until further Order of this Court. For guidance on filings in the District Court please consult the District Court's website at <http://www.lamd.uscourts.gov>. For guidance on filings in Bankruptcy Court please consult the Bankruptcy Court's website at <https://www.lamb.uscourts.gov/>.

All civil and criminal trials (bench and jury) may be resumed. All scheduling is within the sound discretion of the presiding Judge.

All in-court civil evidentiary hearings and other in-court hearings and proceedings requiring personal appearances, on the dockets of the United States District Court and the United States Bankruptcy Court, may be resumed. All scheduling is within the sound discretion of the presiding Judge.

In-court re-arraignments and sentencing hearings may be resumed within the sound discretion of the presiding Judge. All scheduling is within the sound discretion of the presiding Judge.

The authority to resume trials, hearings and other in-court proceedings does not in any way limit the discretion of the presiding Judge to conduct all or part of any proceedings by video conference or telephone conference as previously authorized by the Court and by the CARES Act and which authority is herein extended.

Grand Jury proceedings may be resumed for matters which present exigent circumstances or deemed essential for public safety, subject to approval of the Chief Judge.


Court Unit Executives shall make operational decisions regarding the means and manner of the operations of their respective units, including but not limited to employee telework.

All employees and persons having business in the Russell B. Long Courthouse and Federal Building shall be required to wear masks when in any public space in the buildings, shall observe social distancing, and shall observe all posted signs and placards.

This Order supersedes all previously issued Pandemic related Orders and shall remain in effect until further Order of this Court.
