AMENDED ADMINISTRATIVE ORDER

The Court's previous PANDEMIC RELATED CURTAILED OPERATIONS

Administrative Orders are hereby superseded. This Order shall govern Court operations

until further Order or until rescinded.

1. Extension of CARES Act Authorization

The undersigned, Chief Judge for the United States District Court for the Middle

District of Louisiana, has reviewed the CARES Act authorization of the use of video and

telephone conferencing set forth in Section 15002(b)(1) of the Act. The undersigned Chief

Judge finds that for reasons of health and safety during the continuing COVID-19

pandemic, the Court's Order authorizing proceedings to be conducted by video

conference or telephone conference is hereby extended for an additional 90 days or until

further Order of this Court under the authority of CARES Act § 15002(b)(3)(A).

The public may be permitted to access via audio (listen only mode), to the fullest

extent possible considering technological restraints, video or telephonic hearings by

submitting a request to the chambers of the presiding judge. Contact information for

District Court is available at http://www.lamd.uscourts.gov/directories. Members of the

public and the media are strictly prohibited from recording or broadcasting any hearing,

in whole or in part, in any fashion. Violation of these prohibitions may result in sanctions,

including removal of court issued media credentials, restricted entry to future hearings, denial of entry to future hearings, or any other sanctions deemed necessary by the Court.

## 2. Court Operations

Civil and criminal trials (bench and jury) may be held. All scheduling is within the sound discretion of the presiding Judge.

All in-court civil evidentiary hearings and other in-court hearings and proceedings requiring personal appearances, on the dockets of the United States District Court and the United States Bankruptcy Court, may be held. All scheduling is within the sound discretion of the presiding Judge.

In-court re-arraignments and sentencing hearings may be held. All scheduling is within the sound discretion of the presiding Judge.

The authority to hold in-person trials, hearings and other in-court proceedings does not in any way limit the discretion of the presiding Judge to conduct all or part of any proceedings by video conference or telephone conference as previously authorized by the Court and by the CARES Act and which authority is herein extended.

Grand Jury proceedings may be held with observance of the Court's COVID-19 protocols.

Court Unit Executives shall make operational decisions regarding the means and manner of the operations of their respective units, including but not limited to employee telework.

Pursuant to the authority granted to the Chief Judge presiding over a primary courthouse building and pursuant to the approval granted by the Facility Security Committee governing multi-tenant facilities, fully vaccinated individuals are no longer required to wear a mask and physically distance within the Russell B. Long Federal

Building and United States Courthouse and the U.S. Bankruptcy Court. Individuals who

are not fully vaccinated shall be required to wear masks and physically distance when in

any public space in the facility and shall otherwise observe all posted signs and placards.

This Order does not prohibit individuals from choosing to wear a mask and physically

distancing at any time, regardless of vaccination status. Judicial officers may require staff

and visitors to their respective chambers and courtrooms to wear masks and to observe

physical distancing rules within the sound discretion of the presiding judge. Court Unit

Executives (CUE) may likewise exercise discretion with respect to requiring masks and

physical distancing of staff and visitors to the CUE's offices. The Court and Court Unit

Executives may require proof of vaccination as may be deemed appropriate to protect the

health and safety of unvaccinated employees and others.

This Order supersedes all previously issued Pandemic related Orders and shall

remain in effect until further Order of this Court.
