



NOTICE OF VACANCY

The United States District Court for the Middle District of Louisiana is accepting applications for the position of **Law Clerk – Term** to the Honorable Scott D. Johnson, United States Magistrate Judge.

- The appointment term is at least one year and a day from the date of appointment, with the Judicial Officer having the option to extend the appointment for an additional period of time not to exceed the lifetime limitation defined on page 2.
- Starting salary commensurate with experience. Salary placement may be higher with prior legal work experience in the federal judiciary as a law clerk and bar admission.

POSITION OVERVIEW:

The United States District Court for the Middle District of Louisiana is recruiting for the position of Law Clerk – Term (25-USDC-7). This appointment will last for at least one year and one day from the date of appointment. The preference of the Judicial Officer is to extend the appointment for an additional period of time not to exceed the lifetime limitation as defined below. Prior civil practice experience is preferred. This position is located in the chambers of United States Magistrate Judge Scott D. Johnson and reports directly to the Judge. The Judicial Law Clerk researches issues of law, attends trials and other court proceedings, acts as legal advisor, prepares orders, and makes recommendations based on the law, to the Honorable Scott D. Johnson. The caseload in the jurisdiction is heavy, and the types of cases presented are varied, often involving novel and complex issues of the law. While the nature of the matters presented is serious, the office environment is personable. There is daily interaction with the Judge and other court staff concerning legal and court-related issues.

- Lifetime Limitation – No individual is permitted to serve in the Judiciary for more than four years (whether full-time or part-time) in a Term Law Clerk capacity on or after September 18, 2007. Service as a Term Law Clerk prior to September 18, 2007 will not be counted toward the four-year lifetime limitation.

QUALIFICATIONS & REQUIREMENTS:

Applicants must be United States citizens or eligible to work in the United States. For consideration, an applicant must be a law school graduate (or be certified as having completed all law school studies and requirements and merely awaiting conferment of degree) with an excellent academic record and excellent research and writing skills. Four or more years of graduate legal experience is strongly preferred.

This position requires a detail-oriented self-starter who can maintain strict confidentiality, work well with staff members at all levels, and complete assignments accurately and in a timely manner. Applicants must have excellent communication and organizational skills. Maturity, ethics, and commitment to the law are required. Some travel may be required. Additionally, the applicant must be proficient in computer assisted research, Windows, and Microsoft Word.

LEGAL WORK EXPERIENCE:

Legal work experience is experience in the practice of law, in legal research, legal administration, or equivalent experience received after graduation from law school. Major or substantial legal activities while in military service may be credited, on a month-for-month basis whether before or after graduation, but not to exceed one year if before graduation. Applicants with post-graduation/bar admission legal work experience are preferred.

The table below shows the number of years of legal work experience required for each Judiciary Salary Plan (JSP) grade level/step. Please note that appointment to JSP 12 or above requires that the applicant be a member of the bar of a state, territory, or federal court of general jurisdiction.

- Prior legal work experience in the federal judiciary as a law clerk may increase the starting salary.

BENEFITS:

Employment with the United States Courts offers a generous benefit package, civil and criminal law experience at the federal court level, and an environment providing significant responsibility and challenge. Law Clerks working at least 20-hours per week under term appointments for at least one year and one day are eligible for the following benefits:

Term Law Clerks are not eligible to participate in the Federal Employees Retirement System (FERS/FRAE) or Thrift Savings Plan (TSP).

APPLICATION PROCEDURES:

Qualified applicants must submit a complete applicant's packet by 12:00 PM CST on Friday, June 20, 2025. A complete applicant's packet includes: a letter of interest, a current/detailed resume with class rank and honors, two professional references, a personal writing sample unedited by a third party• (not to exceed ten pages), and a completed Application for Judicial Branch Federal Employment (Form AO-78). Applications for Judicial Branch Federal Employment (Form AO-78) may be downloaded from the court's website lamd.uscourts.gov/employment. You must reference the vacancy announcement number in your letter of interest. Applicant's packets will not be considered complete until all the required items have been received by Human Resources. - If an unedited writing sample is not available, an edited writing sample may be submitted with an explanation.

ADDITIONAL INFORMATION:

The most qualified applicants may be invited to one (or more) personal interview(s) with the Court. Applicants selected for interviews will be required to travel to the designated location at their own expense. The Court is not authorized to reimburse applicants for travel and/or relocation expenses. In-person interviews are preferred, but interviews by video conference will be considered upon request. All applicants who participate in the interview process will receive a written response if they are not selected. Please do not inquire about the status of your application. Prior to appointment, the selectee considered for this position is required to undergo an FBI background check and investigation. The selectee may then be appointed provisionally, and retention will depend upon a favorable suitability determination of the investigation. Unsatisfactory results may result in termination of employment.

The Court requires employees to adhere to a Code of Ethics and Conduct which is available to applicants for review upon request. Employees of the United States Courts are NOT included in the government's Civil Service classification. They are, however, entitled to the same benefits as other federal government employees depending on the appointment type. Employees who work at the Court are considered at-will and work at the pleasure of the Court.

The Court has the right to modify the conditions of this vacancy announcement, withdraw the announcement, or fill the position at any time before the closing date, any of which may occur without prior written notice. The incumbent will be subject to a one-year probationary period.

The Court provides reasonable accommodations to applicants with disabilities in accordance with the Americans with Disabilities Act.
